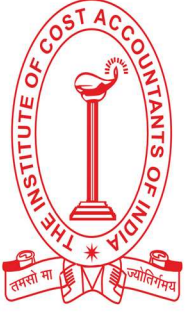

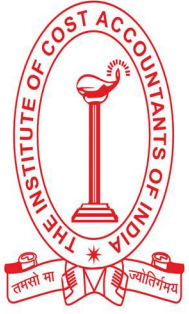
1. Notice Inviting Tender (NIT)

The Institute of Cost Accountants of India invites sealed quotations from reputed, experienced and authorized service providers for undertaking the Comprehensive Annual Maintenance Contract (AMC) of Air Conditioners installed at the Noida Office of The Institute of Cost Accountants of India (ICMAI), CMA Bhawan, C-42, Sector-62, Noida.

Interested firms/companies/agencies fulfilling the eligibility criteria may submit their bids in accordance with the terms and conditions specified in this tender document.

2. GENERAL TERMS AND CONDITIONS

1. The bid shall be submitted in two separate sealed envelopes, namely Technical Bid-cum-Information Sheet (Annexure 1) and Financial Bid (Annexure 2).
 - i. Technical Bid-cum-Information Sheet in separate sealed envelope should be super-scribed with "Technical Bid for Comprehensive Annual Maintenance Contract (AMC) of Air Conditioners of the Noida office of the ICMAI".
 - ii. Financial Bid in separate sealed envelope should be super-scribed with "Comprehensive Annual Maintenance Contract (AMC) of Air Conditioners of the Noida office of the ICMAI".
 - iii. **All documents as per checklist and the sealed envelopes for Technical Bid and Financial Bid should be placed in separate sealed envelope (main envelope) super-scribed with "Bids for Comprehensive Annual Maintenance Contract (AMC) of Air Conditioners at the CMA Bhawan, Noida"**
 - iv. **EMD to be submitted in a separate envelope along with Technical Bid.**
2. The firm shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other company/firm/agency/contractor without the prior written consent of this Institute.
3. The firm will be bound by the details furnished by it to the Institute, while submitting the tender or at subsequent stage. In case, any of such documents furnished is found to be false at any stage, it would be deemed to be a breach of terms of contract making the firm liable for legal action besides termination of contract.
4. Financial bids of only those firms/agencies that are technically qualified shall be evaluated.
5. Tenders without earnest money shall be rejected on the spot and will be considered technically unqualified. However, bidders registered with micro and small enterprises (MSES) as defined in MSE procurement policy issued by the department of micro, small

and medium enterprises (MSME) are exempted from the submission of earnest money (exemption certificate to be submitted).

3. Scope of Work

- Routine servicing (minimum four services per year – quarterly basis)
- Cleaning of filters, cooling coils and condenser coils
- Checking refrigerant gas levels and topping up (if required)
- Checking electrical connections, compressor, thermostat and fan motor
- Attending breakdown complaints within stipulated response time
- Replacement of minor spare parts
- Preventive maintenance and performance testing

Note: Detailed list of AC units is enclosed as Annexure – A.

4. Type of Comprehensive AMC

Comprehensive Annual Maintenance Contract-AMC (Including all spare parts except replacement of compressor)

5. Contract Period

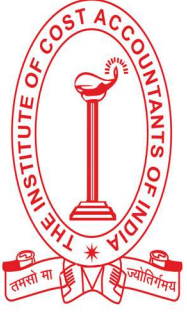
The AMC shall be valid for a period of one year from the date of award of contract. The contract may be extended for a further period of one year, based on satisfactory performance and mutual consent.

6. Eligibility Criteria

- Registered firm/company/agency
- Minimum 3 years' experience in AC maintenance services
- The agency/firm should have a minimum turnover of Rs.10 lakh per year during the last three years (2022-23, 2023-24, 2024-25) should be duly signed by the Chartered Accountant.
- Valid GST registration
- Experience of serving in Government/PSU/Corporate offices
- Submission of PAN, GST and Registration Certificate
- At least two work completion certificates from the reputed organisations.
- The agency/firm should not have been blacklisted by any Govt. Office.

7. Terms & Conditions

- Complaint response time shall be within 24 hours.
- Quarterly preventive maintenance is mandatory.
- Breakdown complaints shall be attended promptly.
- The Institute reserves the right to inspect work at any time.
- Payment shall be released quarterly, subject to satisfactory performance.

- The Institute reserves the right to accept or reject any bid without assigning any reason thereof.

8. PERFORMANCE SECURITY

To ensure due performance of the contract, Performance Security of Rs. 30,000/- (Rupees Thirty thousand only) to be paid by the successful bidder to whom the contract was awarded. Performance Security may be furnished in the form of an account payee demand draft or bank guarantee from a commercial bank or online payment.

B. Performance Security shall remain valid for thirty (30) months from the date of commencement of the contract. No interest would be paid on the amounts.

C. The Institute reserves the right to deduct appropriate amount from the Security deposited in lieu of any unpaid statutory dues or any other dues. In case of pendency of any dispute related to non- payment/less payment of salary/noncompliance of statutory obligations by the contracting bidder which may results into financial liabilities for the Institute, in such cases the Institute reserves its right to withhold such Performance Security deposit for a period beyond six months after expiry / termination of the contract or otherwise the amount will be refunded without any interest.

9. Payments

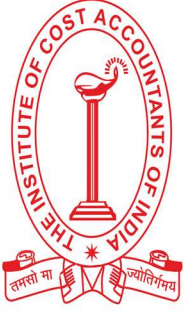
- No advance payment will be made. Payment will be made on quarterly basis after completion of satisfactory supply and submission of invoice / bill in hard copy. Taxes will be extra as applicable.
- The payment will be made in electronic mode only within 15 days of submission of bills.

10. Penalty Clause

Time is the essence of the services. The minor repairs will be completed within 8 hours (i.e servicing, small repair works, gas filling which does not require any bought out material). The major repair work (PCB & Compressor problems) is to be completed in all respects in 3 (Three) days from the date of Complaint. In case of any delay beyond 8 hours for minor & 3 days for major repair works, supplier has to arrange standby AC. If the bidder fails to arrange standby AC, penalty will be imposed @ 1% of the contract value per day of delay of the particular quarter.

11. Jurisdiction

All disputes shall be subject to the jurisdiction of courts at New Delhi only.

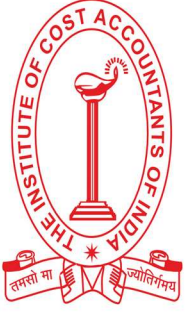
