Tender Notice

Name of Work

Supply, Fabrication, Installation, Testing and Commissioning of Main Stage Curtain, Side Wings and Associated Motorized Curtain System at J. N. Bose Auditorium, CMA Bhawan, Kolkata.

1. Scope of Work

The contractor shall design, supply, fabricate, install, test and commission a complete motorized auditorium curtain system including the Main Curtain, Stage Wings, Track Mechanism, Motorized Operating System, Structural Supports and all allied accessories required for satisfactory operation.

The work shall be executed in accordance with the specifications provided herein and to the satisfaction of the Administration Department.

2. Technical Specifications

Item No. 1 – Main Stage Curtain

Supply, fitting and fixing of premium quality auditorium curtain made from high-quality velvet (fire-retardant) finish fabric suitable for stage applications.

The curtain shall comprise:

- Double gathering arrangement.
- Decorative tassels and finishing accessories.
- New roller ball fittings.
- Heavy-duty curtain operating mechanism.
- Motorized opening and closing system.
- One (1) HP, 3-Phase branded motor complete with:
 - Push button station.
 - Air-break connector.
 - LT/Timer control arrangement.
 - Main control panel.
- Necessary pulley system.
- Roller bobbin arrangement.
- Steel wire rope and allied accessories.
- Complete installation and commissioning.

For a complete dimension and area of work, vendor are requested to visit the site.

Logo Embossing Requirement

The center portion of the Main Curtain shall prominently display the Official Logo of The Institute of Cost Accountants of India (ICMAI).

The logo shall be:

- Embossed / embroidered / appliqué finished.
- Centrally positioned.
- Proportionately sized to auditorium dimensions.
- Approved by the Institute prior to fabrication.
- Durable and colourfast.

Item No. 2 – Motorized Curtain Box and Structural Framework

Providing, fitting and fixing curtain box fabricated from M.S. square tube structure of suitable size including:

- 2" × 1" and 1" × 1" M.S. square tubes.
- Complete welded framework.
- 12 mm BWR plywood lining.
- Enamel paint finish.
- Necessary supports and anchoring arrangements.
- Height and dimensions as directed by Engineer-in-Charge.

Item No. 3 – Stage Wings

Supply, fabrication and installation of Stage Legs/Wings measuring approximately 11 ft × 3 ft each.

The wings shall consist of:

- 25 mm × 25 mm medium gauge M.S. tube framework.
- Horizontal members at 600 mm c/c.
- Four vertical members equally spaced.
- Complete welding and grinding.
- Black synthetic enamel paint finish (two coats).
- One side covered with 6 mm thick BWR plywood.
- Approved quality black cotton fabric finish.
- Heavy-duty pivot arrangement.
- Roller bearing mechanism for rotational movement.
- Channel-mounted sliding arrangement.
- Two castor wheels at bottom of each wing.
- Smooth movement and operation.
- Complete installation as directed by Engineer-in-Charge.
