State Health Society, NHM, U.P. invites “Technical Bid” and “Financial Proposals” from firms of Chartered Accountants & Cost Accountants which meet all the conditions in the eligibility criteria listed below, for carrying out monthly concurrent audit of SHS for the F.Y. 2017-18 as per the Terms of Reference (TOR).

**Eligibility Criteria :** The firm must (a) be empanelled with C & AG for 2016-17 (b) must have Head office or branch office at Lucknow (c) The firm must be five year old. Audit firms applying should submit documentry proof for all the above criteria. Technical and financial bid should be submitted in separate envelope superscribed Technical and financial bid respectively. Both envelop will be kept in main envelop which will be supperscribed on the top of envelop “**Proposal for concurrent auditor for State Health Society, UP**” should be superscribed.
