**CORRIGENDUM-I**

Name of work: - Appointment of Chartered Accountancy Firm/Cost Accountancy firm for Internal Audit of HPSIDC Limited for the period Oct-26 to Mar-28.

Due to administrative reasons, amendments in the tender documents w.r.t Internal Audit services, the key dates are hereby rescheduled as per detail given below.

**Point of Consideration: - Point No. 7 of Annexure-A of the Tender Notice for Internal Audit Services**

It is submitted that the Institute of Cost Accountants of India (ICMAI), vide its email dated **31.08.2026**, has raised a query with regard to **Point No. 7 of Annexure-A of the Tender Notice for Internal Audit Services**, wherein empanelment of the Cost Accountants firm with the **Comptroller and Auditor General of India (C&AG)** has been prescribed as a prerequisite for undertaking the Internal Audit assignment.

The representation made by the Institute has been duly considered. Accordingly, it is proposed that the requirement of **C&AG empanelment relaxed in respect of Cost Accountants firms**, thereby enabling eligible Cost Accountants firms to participate in the tender without the requirement of C&AG empanelment.

However, **Point No. 7 of Annexure-A shall continue to remain applicable to Chartered Accountants firms**, and the requirement prescribed therein regarding C&AG empanelment shall be applicable to Chartered Accountants firms participating in the tender.

Accordingly, the tender document may be suitably amended/clarified to give effect to the above relaxation in respect of Cost Accountants firms, while retaining the existing eligibility condition for Chartered Accountants firms.
